We have reviewed your May 20, 2019, request for a cultural resources assessment, received on May 21, 2019, for the above referenced project in accordance with our responsibilities under Section 106 of the National Historic Preservation Act and 36 CFR Part 800. After reviewing the information provided, we offer the following comments:

Eighteen proposed restoration projects recommended in response to "Deepwater Horizon" Oil Spill. Ten of these projects were determined to have potential effects in uses or resources of the coastal zone that target the following: Fish and Water Column Restoration (restore injured fish species & increase health of fishery resources; Sea Turtle Restoration (reduce primary threats, restore injured sea turtles across geographic ranges, support existing conservation efforts); Marine Mammal Restoration (restore injured bay, sound, estuary, coastal, shelf, and oceanic marine mammals, mitigate key stressors, address direct human-caused threats like vessel strikes and noise); and Mesophotic and Deep Benthic Communities Restoration (restore injured communities, manage habitats, improve understanding of communities).

Statement made that above projects do not have adverse effects to:

Air Quality, noise, surface water quality, and contaminant loading to surface waters from vessels that port or land catch in Mississippi.

Shorelines, habitats, or substrates or cause any other physical change to the Mississippi's coastline.

Any aesthetics in coastal environment.

Existing infrastructure in coastal environment.

Health and safety at port or vessels operating in/transiting coastal environment.

Concur provided that any coastline or marine activities avoid known/identified/recorded or charted terrestrial and/or submerged resources. With this condition, we have no objection with the proposed undertaking.

Should there be additional work in connection with the project, or any changes in the scope of work, please let us know in order that we may provide you with appropriate comments in compliance with the above referenced regulations.
