**Request description**

Pursuant to the Massachusetts Public Records Act, M.G.L. c. 66 § 10, I am requesting records pertaining to the Parker River National Wildlife Refuge/US Fish and Wildlife Service (FWS) purchase of the house at 60 Plum Island Turnpike in Newbury, MA, commonly known as “The Pink House” (TPH). This should include any and all internal or external documents, emails, call logs, printed media or communications regarding the details of the September 2011 sale of the House, known as The Pink House, + 3 parcels totaling 9.29 acres. It is listed as belonging to the USA. I am only able to access the simple record of the exchange between owner Bruce Stott and the US Fish and Wildlife Service, and the purchase price of \$375,000 in September 2011. I am requesting: All correspondence as to why FWS purchased the house and parcels from inception of the topic, assuming at least as far back as 09/1/2010 to 07/31/2014. And, all records denoting it was purchased by – whether the US Fish and Wildlife Service or another entity (like the Friends of the Parker River Wildlife Refuge) and donated or given to the Fish and Wildlife Service or Parker River National Wildlife Refuge. Also, the signed real estate transaction documents, all purchase offers, the Purchase and Sale agreement, any real estate documents from 2011 and after, and any emails that pertain.
