This is a unit of the National Wildlife Refuge System, a network of lands and waters managed for the benefit of wildlife and people.

General Introduction

Bald Knob National Wildlife Refuge, established in 1993, is one of 568 national wildlife refuges administered by the U.S. Fish and Wildlife Service. The primary objective of the refuge is to provide habitat for migratory waterfowl. The refuge is located in White County, Arkansas.

Hunting, fishing, wildlife observation and photography, environmental education, and interpretation are priority public uses of the National Wildlife Refuge System. These wildlife-dependent uses are carefully managed on Bald Knob National Wildlife Refuge to ensure they are compatible with refuge purposes and provide safe, high-quality, low-impact, recreational opportunities. Users of the refuge must obey all signs pertaining to visitation, access, and public use regulations. All public uses, including hunting and fishing, are conducted in accordance with state and federal regulations as supplemented by the following special refuge regulations.

Access and Vehicle Use

The entire refuge, including the Mingo Creek Unit, is CLOSED to all other entry and public use during the Quota Gun Deer Hunt Nov. 9 - 10. Only Quota Gun Deer permit holders are allowed to enter or use the refuge during this hunt and only for the purpose of quota gun deer hunting and the incidental take of beaver, muskrat, nutria, coyote, striped skunk, fox, bobcat, river otter, mink and feral hogs. **Exception:** If Flood Prone Region B is closed to deer hunting due to flooding during the refuge's Quota Gun Deer Hunt, then the refuge will be open to other public entry and use.

The Mingo Creek, Bison, and Waterfowl Sanctuary Units will be closed to all other entry and public use during the Youth Quota Turkey Hunt (see AGFC regulations for Youth Turkey Dates). Only Youth Turkey Hunt permit holders are allowed to enter or use these refuge units during this hunt and only for the purpose of youth turkey hunting.

Waterfowl sanctuaries, indicated on the refuge map, are closed to ALL entry and public use, including hunting and fishing, from Nov. 15 through Feb. 28 annually.

Conventional vehicles may only be used on the Bison, Waterfowl Core, and Sanctuary Units and ONLY from Mar. 1-Nov. 14. Conventional vehicles must meet all applicable federal and state requirements regulating the use of licensed motor vehicles. Vehicles equipped with oversize tractor lug type tires are prohibited. Use of conventional vehicles is prohibited on the Mingo Creek Unit year-round. Speed limit for motor vehicles (including ATV/UTVs, ebikes, etc.) is 25 mph unless otherwise posted.

Recreational use of ATV/UTVs is not allowed. ATVs may ONLY be used Sep. 1 to Mar. 31 and ONLY to provide access for hunting. ATV/UTVs may be used after Mar. 31 ONLY for goose hunting during the State Conservation Order.

All-terrain vehicle" or "ATV" means any motor vehicle, designed for off-highway use, and designed to travel on not less than three low-pressure tires, having a seat or saddle designed to be straddled by the operator and handlebars for steering control and intended by the manufacturer to be used by a single operator or by an operator and no more than one passenger. "Utility terrain vehicle" means any motor vehicle with four or more low-pressure tires designed for off-highway use having bench or bucket seating for each occupant and a steering wheel for control. Mini-trucks or other modified off-road vehicles are prohibited. ATVs/UTVs exceeding the manufacturers dry weight of 1750 lbs are prohibited. ATVs/UTVs may not have tires with tread/lugs greater than 1 ¼". **NEW**

2024-2025 General Hunting and Fishing Permit— Bald Knob NWR

This permit must be signed to be valid. Individuals hunting or fishing must carry it at all times while on the refuge and in possession of hunting and fishing gear. An electronic signed copy of the permit may also be produced on a person's own cellular phone or other type of portable electronic device that clearly displays and accurately reproduces all of the information. This permit expires 07/31/2025.

I have read and understand the refuge hunting and fishing regulations and agree to obey them and agree to allow USFWS and AGFC officers to inspect or search all my equipment used during my visit.

Signature (Permit not transferable)

Prohibited Activities Include:

- Open alcohol containers on refuge roads, ATV trails, parking areas, boat ramps, fishing piers, or observation decks.
- Swimming.
- Camping.
- Building fires.
- Cutting or defacing trees, shrubs, or other plants
- Littering (including, but not limited to, shotgun shell hulls and cigarette butts).
- Searching for or removal of artifacts.
- Use of horses or mules.
- Possession or use of fireworks.
- Commercial hunting/fishing/guiding.
- Driving on the Little Red River Protection Levee.
- Houseboat mooring to the refuge bank on the Little Red River.
- Off road vehicling, or driving conventional vehicles on wet/ muddy ungraveled roads.
- Taking or possessing turtles or mollusks
- Use of artificial lights to locate wildlife except as authorized for fishing, frogging, and raccoon/ opossum hunting.
- Use of firearms and possession or use of archery equipment and crossbows except during refuge hunts that allow their use.
- Loaded hunting firearms or muzzleloaders in or on a vehicle, ATV, or boat under power. "Loaded" is defined as having shells in the firearm or an ignition device on/in the muzzleloader.
- Target practice or non-hunting discharge of firearms.
- Failure to remove all marking materials from the refuge following the hunt.
- Use of drones
- Tournament fishing

Conventional vehicles, bicycles, ebikes, and ATV/UTVs are not allowed in fields and must stay on maintained roads, levee tops, or established parking areas at all times.

The Core Waterfowl Area and waterfowl draw units will be closed from Nov. 15 -Feb. 28 annually to ALL public entry and use after 1 pm to reduce waterfowl disturbance and improve hunt quality (see map).

During this period, Coal Chute Road, Granary West Road parking area and Frackin Road will remain open to vehicular access. NOTE: This closure will NOT apply to all-day hunting for geese during the State Conservation Order.

Roads may be closed any time conditions or other administrative needs warrant. A locked gate or other barrier, road closed sign, or no vehicle sign means the road is closed to ALL vehicle travel, including bicycles and ebikes, but not to foot travel unless signed otherwise.

Bicycles and ebikes may only be operated on roads or trails designated for conventional vehicles and/or ATV/UTVs. Parking of vehicles on roadsides that prevents the passage of extra-wide farm equipment is prohibited. Vehicles are subject to be towed at the owner's expense.

Personal watercraft (jet-ski, etc), hover craft, and airboats are prohibited. Boats may not be left overnight on the refuge.

General Refuge Regulations

Public use of the refuge is permitted throughout the year. Permitted activities are hunting, fishing, wildlife observation, photography, environmental education, and interpretation.

The refuge is open for public entry and use, including hunting and fishing, from 5am to one hour after legal sunset, except for those engaged in raccoon/opossum hunting at night and possessing the appropriate equipment and required hunting license. Hunters trailing or retrieving deer after hours should call the refuge office at 501/724 2458 and leave a message stating their name, phone number and the general area in which they are searching for or retrieving deer.

Sport Fishing Regulations

A signed refuge fishing permit from the front of this brochure is required for all fishing activities. Permits are non-transferable and must be signed by the individual and carried at all times while on the refuge in possession of fishing gear. An electronic signed copy of the permit may also be produced on a person's own cellular phone or other type of portable electronic device that clearly displays and accurately reproduces all of the information.

Sport fishing, frogging, and crawfishing, for personal use only, are permitted year-round in accordance with state seasons and state and refuge-specific regulations. The owner's Arkansas Game and Fish Commission license customer ID number must be permanently affixed to each crawfish trap. Anglers (including those frogging, crawfishing, and bow fishing) may enter the refuge no earlier than 5:00 a.m. and must depart the refuge by 1 hour after legal sunset. **NEW**

A limited number of Nighttime Frogging Permits will be available this year. Permits will be sold on a first come, first serve basis for the first two weekends of the frogging season. Sales will be open from March 15 through April 5th. Visit <https://baldknob.recaccess.com/> for details. **NEW**

Prohibited hunting activities include:

- The use of dogs for deer hunting.
- We prohibit leaving any tree stand, ground blind, or game camera on the refuge without the owner's Arkansas Game and Fish Commission license customer ID number clearly written in a conspicuous location.
- Driving or screwing any metal object into a tree or hunting from a tree in which a metal object has been driven or screwed to support a hunter.
- Building or hunting from permanent blinds or stands.
- Hunting from a vehicle or use of a vehicle as a deer stand.
- Possession or distribution of bait or hunting over bait, salt, grain, or other feed that could serve as a lure or attraction for wildlife.

General Hunting Regulations

A signed refuge hunting permit from the front of this brochure is required for all hunting activities. Permits are non-transferable and must be signed by the hunter and carried at all times while on the refuge in possession of hunting gear. An electronic signed copy of the permit may also be produced on a person's own cellular phone or other type of portable electronic device that clearly displays and accurately reproduces all of the information. A permit is located on the front of this brochure or can be downloaded and printed from the refuge website at <http://www.fws.gov/baldknob>.

Additional permits are required for the Quota Gun Deer, Quota Youth Turkey Hunts, Nighttime frogging hunts, and waterfowl draw areas. Hunter Orange or Chartreuse must be worn in accordance with Arkansas Game & Fish Commission regulations during Quota Gun and Muzzleloader Deer hunts.

Portable, pop-up blinds must have 144 square inches of blaze orange or chartreuse visible from all sides of the blind during firearm big-game seasons on the Refuge.

Bag limits for all species, except deer, are the same as state limits.

Dog training is allowed Sept. 1- Apr. 1.

Mobility Impaired Hunters

Mobility-impaired hunters may apply for a refuge Special Use Permit allowing the specialized use of ATVs on existing roads and trails. For more information, please call the refuge at 501/724 2458.

Hunter Education and Youth Hunter Supervision

All hunters age 11 and younger who possess valid hunter education certification must remain within normal sight and voice contact with an adult age 18 or older who possesses a valid State hunting license. Hunters age 15 and younger who have not completed hunter education must be under the direct supervision (within arm's reach) of an adult age 21 or older who possesses a valid State hunting license. One adult may supervise up to two youth hunters for migratory bird and upland game hunting, but may supervise only one youth during big game hunting.

Specific Hunting Regulations

The entire refuge, including the Mingo Creek Unit, is CLOSED to all other entry and public use during the Quota Gun Deer Hunt Nov. 9-10. Only Quota Gun Deer holders are allowed to enter or use the refuge during this hunt and only for the purpose of deer hunting and the incidental take of beaver, muskrat, nutria, coyote, striped skunk, fox, bobcat, river otter, mink, and feral hogs according to any applicable state seasons and regulations. Exception: If Flood Prone Region B is closed to deer hunting due to flooding during the refuge's Quota Gun Deer Hunt, then the refuge will be open to other public entry and use.

The Mingo Creek, Bison, and Waterfowl Sanctuary Units will be closed to all other entry and public use during the Quota Youth Turkey Hunt (see AGFC regulations for Youth Turkey dates). Only Youth Turkey Hunt permit holders are allowed to enter or use these refuge units during this hunt and only for the purpose of youth turkey hunting.

Migratory Birds

Only non-toxic shot may be possessed or used for all migratory bird hunting.

Waterfowl (Duck, Coot, Merganser, and Geese): State Seasons. State bag limit(s) apply. Dogs permitted.

Morning until 12 noon hunting only, throughout the entire season, including the State Youth Hunts, and Special Active Duty Military and Veterans hunts. (Exception: all day hunting permitted for geese during the State Conservation Order)

Shotgun shell possession limit - 25 daily, except for goose hunting under the State Conservation Order.

Specific areas have been designated as "waterfowl draw hunt areas" These areas are closed to all other entry during Fridays, Saturdays and Sundays and all opening days during the regular waterfowl season. See map and website for details. **NEW**

Unless specifically noted, waterfowl hunting areas are first come first serve. Waterfowl hunting groups or individuals may not join another group or individual unless it is agreed upon by the first hunting group or individual to arrive at a location. If not agreed upon by the first group, the second or subsequent group(s) or individual(s) to arrive should depart from the area immediately. All hunting parties must maintain a minimum distance of 100 yards apart. **NEW**

Waterfowl hunters may enter the refuge no earlier than 5 am, except to park in the Huntsman/Granary West parking area accessed from Safely Road prior to 5 am. Waterfowl hunters are not allowed to travel past the gate from this parking area before 5 am. **NEW**

Waterfowl hunters may not assemble, stage or line up for entry into the refuge prior to 12 am during any part of the early or regular waterfowl seasons.

Hunters must pick up and remove their spent shell casings and boxes from the refuge. Decoys, blinds, boats, and all other equipment must be removed daily by 1 pm.

It is unlawful to possess, or take or attempt to take waterfowl with the use of, any simulated wing movement decoy or any decoy other than an artificial decoy that imitates the appearance of waterfowl: no moving parts or electrical components; and is not subjected to any artificial means that makes it appear to move, splash or cause ripples from the first day of the first segment of regular duck season through the last day of the last segment of regular duck season, including teal and youth waterfowl season. Exception: Manually operated "jerk strings" may be used to simulate decoy movement. **NEW**

Cutting of holes or other manipulation of vegetation (cutting bushes, mowing, weed-eating, etc.) or hunting from manipulated areas is prohibited.

Dove: State seasons* Dogs are permitted.

Snipe: State seasons* Dogs are permitted.

Woodcock: State season.* Dogs are permitted.

Crow: State season.* Dogs are permitted.

Rail (Virginia and Sora): State seasons.* Dogs are permitted.

Gallinule (Common and Purple): State seasons.* Dogs are permitted.

Small Game: Only rifles and handguns chambered for rimfire cartridges, air rifles, archery tackle, or shotguns with non-toxic shot may be used for all small game hunting.

Squirrel: Sept. 1 - Feb. 28 * Dogs are permitted. Note: No road hunting allowed.

Rabbit: State season.* Dogs are permitted.

Quail: State season.* Dogs are permitted.

Furbearer: Beaver, muskrat, nutria, coyote, striped skunk, fox, bobcat, river otter, and mink may be taken incidental to any refuge hunt by the use of the device appropriate for that hunt and according to any applicable state seasons and regulations.

Feral Hog: In cooperation with the Arkansas Game and Fish Commission's Feral Hog Control Program, feral hogs may only be taken on the refuge during the quota gun, youth gun, and muzzleloader deer hunts and by archery deer hunters. Feral hogs are destructive and non-native animals that are incompatible with refuge management. Live hogs may not be possessed, transported, or released on the refuge. **NEW**

Raccoon: Sep.1 - Mar. 31.* Dogs are required for hunting raccoons at night. Waterfowl sanctuary is closed to all hunting from Nov. 15 - Feb. 28.

Opossum: Sep.1 - Feb. 28 * Dogs are required for hunting opossum at night. Waterfowl sanctuary is closed to all hunting from Nov. 15 - Feb. 28.

Big Game: For all deer and turkey harvested on the refuge, "Bald Knob NWR" must be used instead of a zone number for tagging and checking your game. All deer harvested during the Quota Gun Deer Hunt MUST be checked at the Refuge Headquarters. In addition, all deer and turkey harvested on the refuge also must be checked according to state regulations.

Only portable stands may be used and the owner's Arkansas Game and Fish Commission license customer ID number must be permanently affixed to the stand. A portable hunting stand is any device or structure used for the purpose of hunting that can be carried in its entirety and erected by hand including but not limited to tripod stands, lean-to stands, lock-on stands, ladder stands and climbing stands. Stands may be erected 7 days prior to the refuge deer season and must be removed from the waterfowl sanctuaries prior to Nov. 15 and from the rest of the Refuge within 7 days of the closing of archery season.

Deer Limits and Refuge Legal Buck Definition: A legal buck on the Refuge is defined as any male deer (no antler restriction). Deer harvested on the Refuge are NOT bonus deer. Refuge wide season limit is four deer, no more than two bucks, which may include:

Deer (Archery/Crossbow): State season.* Either sex. State limit applies. (Velvet Hunt is private land/Commission owned property only)

Deer (Muzzleloading): Alternative Firearms State season. Two deer limit. One buck and one doe. Limited to muzzleloaders shooting a single projectile. Straight-walled cartridges prohibited. **NEW**

Deer (Youth Gun): Nov. 2-3. One buck and one doe, or two does. Legal centerfire rifles are permitted on the Mingo Unit only. The remainder of the refuge is restricted to shotguns with slugs, muzzleloaders shooting a single projectile, non-semiautomatic centerfire firearm which fires a straight-walled rifle cartridge .30 caliber or larger, and legal handguns and air rifles as defined by the Arkansas Game and Fish Commission may be used.

Deer (Quota Gun): Nov. 9-10 Refuge-wide. Quota hunt permit required. Two deer limit. One buck and one doe.

Legal centerfire rifles are permitted on the Mingo Unit only. The remainder of the refuge is restricted to shotguns with slugs, muzzleloaders shooting a single projectile, non-semiautomatic centerfire firearm which fires a straight-walled rifle cartridge .30 caliber or larger, and legal handguns and air rifles as defined by the Arkansas Game and Fish Commission may be used.

A Bald Knob NWR Quota Gun Deer Hunt permit does not entitle you to camp on State WMAs during the refuge Quota Gun Deer hunt.

To apply for a quota hunt permit Hunt permits are \$12.50 and must be purchased from baldknob.recaccess.com. Quota permits issued beginning Aug. 1 on a first come, first served basis until the quota is reached, or until Oct. 31.

Permit requests will NOT be accepted in person. Permits are non-transferable and nonrefundable, even in the event of refuge deer hunt closures due to flooding.

The refuge is located in AG&FC Flood Prone Region B. The refuge will close to all deer hunting when the White River gauge at Augusta reaches 31 feet, as reported at weather.gov/lmrfc/. This restriction is lifted when the gauge at Augusta falls below 30 feet and the White River gauge at Georgetown falls to, or below, 19 feet.

Signs Protect Visitors and Resources

Millions of people visit national wildlife refuges each year. The impact of human activity, if not regulated, can degrade these wildlands. Signs control recreational activities while protecting natural resources on the Refuge. Please respect the refuge signs identified in this brochure.

Area beyond this sign closed. All public entry prohibited. Area closed to all public use. Some areas such as waterfowl sanctuaries are only

seasonally closed. Seasonally closed areas have the specific closure dates printed on the face of the sign.

Turkey (Youth Quota Gun): Quota hunt permit required. Mingo Creek, Bison, and Sanctuary Units Only. State Youth Turkey Season. Youth will be assigned an area to hunt. Hunt permits are free, but must be obtained from baldknob.recaccess.com Mar. 1 through Mar 15. Contact the refuge office at 501/724-2458 for additional details.

NEW Regulation Summary:

Both hunting and fishing activities now require the General Hunting and Fishing Permit that is found on the cover of the Regulations Brochure.

ATVs/UTVs exceeding the manufacturers dry weight of 1750 lbs and tire tread/lug greater 1 ¼” are prohibited.

A limited number of Nighttime Frogging Permits will be sold during the first two weekends of the frogging season.

Refuge entry time for all activities is 5:00 am













Waterfowl Draw Hunt Areas have been designated and are closed to all other entry Fridays, Saturdays and Sundays and all opening days during the regular waterfowl season.

Unless specifically noted, waterfowl hunting areas are first come, first serve. Waterfowl hunting groups or individuals may not join another group or individual unless it is agreed upon by the first hunting group or individual to arrive at a location. If not agreed upon by the first group, the second or subsequent group(s) or individual(s) to arrive should depart from the area immediately.

Muzzleloader season will be limited to muzzleloaders shooting a single projectile only. Firearms which fire a straight-walled rifle cartridge .30 caliber or larger are prohibited during the Alternative Firearms (formerly muzzleloader) season.

Feral hogs may be taken incidentally during the entire archery deer season.
