#### Helpful Hints

When visiting, be prepared for natural and climatic conditions. Wear layers on cooler days. Use insect repellent and sunscreen, as necessary during the summer months. Wear comfortable shoes. Bring binoculars to get the best views of wildlife. Don't forget to bring a sufficient amount of drinking water.

To make the most of your visit, take a deep breath and soak in the sights and sounds of unspoiled habitats. Disconnect from the modern world and reconnect with nature.

#### Regulations

Please follow these regulations to ensure your safety, maintain native habitats and preserve a high quality experience for future users.

Access to the island is to occur only in concert with refuge-sponsored public use events or by Special Use Permit. Unauthorized entry to the refuge is prohibited.

Please stay on designated trails during your visit to the refuge.

In an effort to avoid potential animal conflicts, no pets are allowed.

Licensed fishing is welcome in adjacent waters, but no fishing is allowed from the refuge,

Employ Leave No Trace philosophy. Please leave with everything you came with, especially trash.

Please do not impact the experience of future visitors by disturbing animals, plants, or natural history materials. Collection and removal of any of these are prohibited.

Surface collecting or digging for archaeological, historical, and/or American Indian artifacts, or for any other reason, is strictly prohibited. Stiff penalties, even imprisonment, can result from such action.

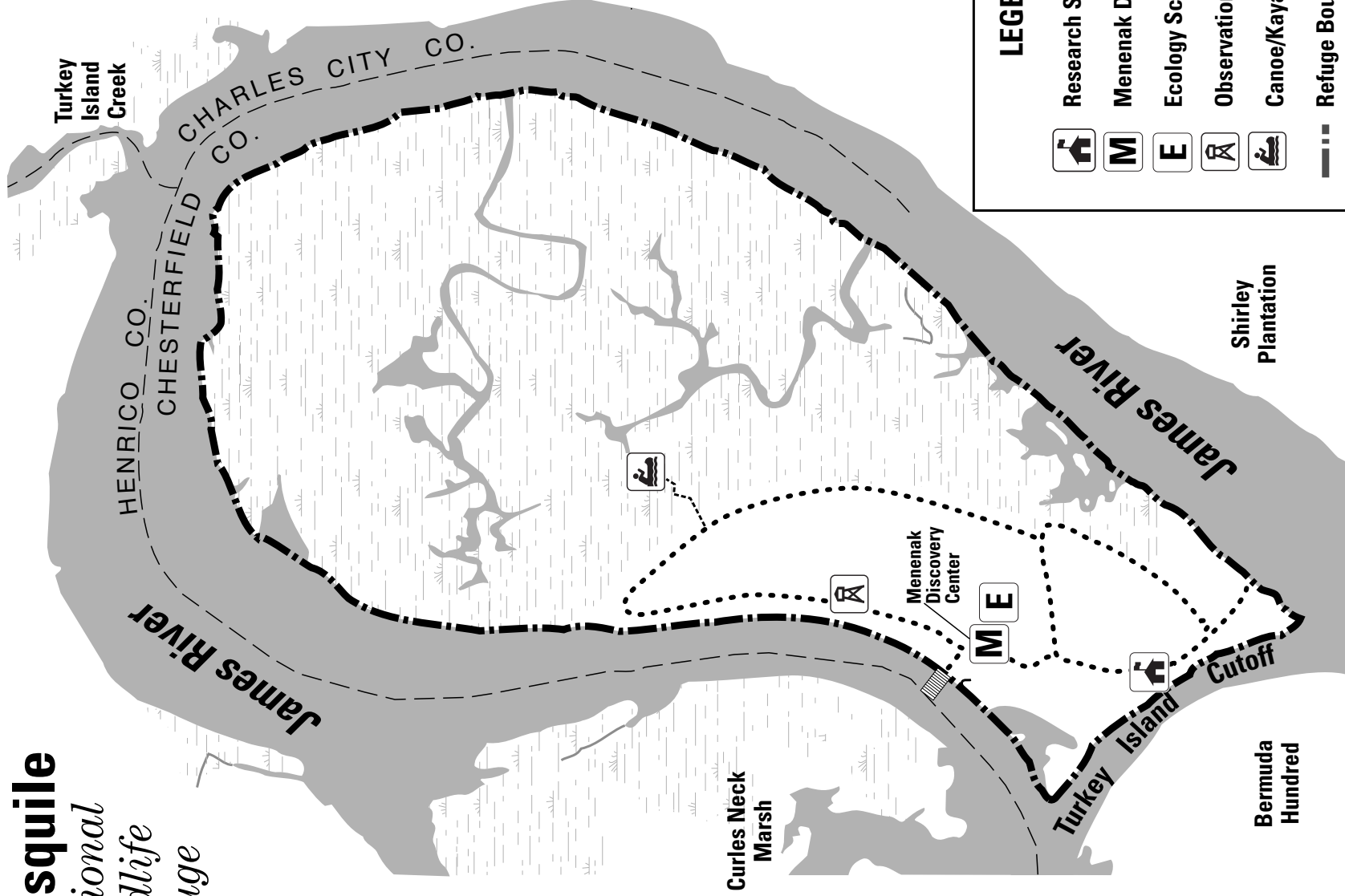
